The maximum total levies payable in the 2015/16 financial year per member business is \$75,000+GST. In the case of official co-productions, the levy is payable only on the Australian component of the budget. The levy is considered a Qualifying Australian Production Expenditure (QAPE) for the purpose of the Producer Offset. Levies are payable on the first day of principal photography.
